#### Overview:

This director drives a number of work streams in the effort to disrupt the venture capital landscape. This role is designed for a self-motivated and ambitious individual who is passionate about propelling female-founded businesses forward, bringing many more women investors into the early-stage sectors, and changing the venture capital culture towards greater equity and diversity.

Job Duties and Responsibilities (including but not limited to):

- Drive our efforts to engage 10,000 new women investors in venture through our own network of 16,000 women, partnerships with 20-40 organizations, engaging new audiences and recruiting venture capital fund participants.
- Own end-to-end planning, project management and execution of national education and marketing campaigns aimed at women accredited investors including emails, webinars, media, speaking engagements, and other marketing efforts in collaboration with the How Women Lead marketing team
- Recruit, manage, and inspire a team of volunteer ambassadors to amplify campaigns to disrupt venture capital and engage 10,000 new women investors. Act as primary motivator and point of contact for all communications, volunteer meetings, volunteer led events and volunteer activities.
- Manage timely delivery of campaign progress reports
- Ensure campaign strategies are implemented in concert with and complementary to existing initiatives and larger organizational goals
- Ensure that the campaign remains a top organizational priority
- Strategize with the How Women Lead marketing team to develop and review monthly How Women Invest newsletter content.
- Cultivate strong strategic relationships and advance partnerships with other actors in the venture ecosystem including VC firms, professional associations, publications, and individual investors to collaborate on mission-related projects, movement building, and awareness
- Define and take action on inspiring behavior change by asset allocators to invest more in women's funds; support research, writing and a conference
- Work with research firm(s) to envision, implement and promote results of research
- Plan and execute all aspects of regular monthly and quarterly How Women Invest events including setting agenda, topics, recruiting and communicating with speakers and hosts, developing event descriptions and collateral for marketing purposes. Supervise How Women Invest Event & Community Coordinator.
- Work with policy makers on legislative initiatives that move capital to women founders and VCs
- Manage and cultivate committee of national leaders

### **Additional Expectations:**

- Attend selected in-person and virtual How Women Lead events
- Availability during regular PST business hours, and flexibility during evenings and weekends as needed to attend events or peak periods of work

- Availability to work remotely with colleagues at different locations
- Be ready to take initiative to dive in and do the work. You will be an implementer and executor of ideas as much as a work-flow and project manager.
